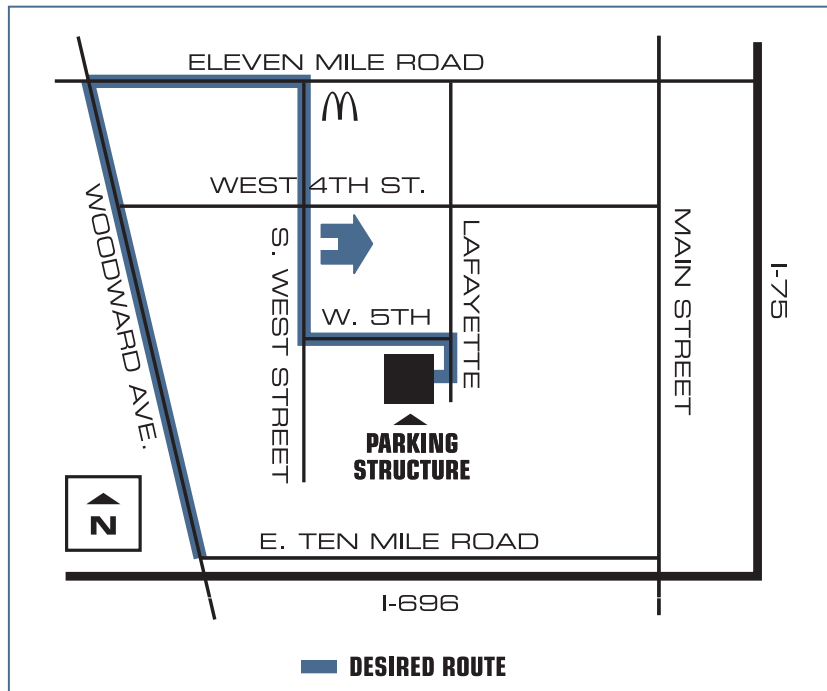

PARKING

Please use parking structure or metered parking located on W. 5th street.
Parking on S. West street will result in a \$50 fine.

DRIVING DIRECTIONS

From Detroit (East Side) - including Port Huron: I-94 west to I-696 west to I-75 north to 696 west. Take Exit 16 toward M-1 / Woodward Avenue north / Main Street / Detroit Zoo. Stay straight to go onto east 10 Mile Road. (Now please see LOCAL DIRECTIONS below to continue)

From Detroit (West Side) - including Kalamazoo, Battle Creek, Jackson, and Ann Arbor: I-94 east to I-275 north to I-696 east. Take Exit 16 toward M-1 / Woodward Avenue north / Main Street / Detroit Zoo. (Now please see LOCAL DIRECTIONS below to continue)

From West - including Grand Rapids and Lansing: I-96 east to I-696 east. Take Exit 16 toward M-1 / Woodward Avenue north / Main Street / Detroit Zoo. (Now please see LOCAL DIRECTIONS below to continue)

From North - including Bay City, Saginaw and Flint: I-75 south to I-696 west. Take Exit 16 toward M-1 / Woodward Avenue north / Main Street / Detroit Zoo. Stay straight to go onto east 10 Mile Road. Take Woodward Avenue north to Eleven Mile Road east. (Now please see LOCAL DIRECTIONS below to continue)

From South - including Toledo and Monroe: I-75 north to I-696 west. Take Exit 16 toward M-1 / Woodward Avenue north / Main Street / Detroit Zoo. Stay straight to go onto east 10 Mile Road. (Now please see LOCAL DIRECTIONS below to continue)

From Metro Airport - take I-94 east to Southfield Freeway north. Take Southfield Freeway north to Southfield Road. Take Southfield Road north to I-696 east. Take Exit 16 toward M-1 / Woodward Avenue north / Main Street / Detroit Zoo. (Now please see LOCAL DIRECTIONS below to continue)

LOCAL DIRECTIONS

Take Woodward Avenue north to Eleven Mile Road. Make a right turn (east) on Eleven Mile Road. Look for the McDonald's Restaurant. Make a right immediately before McDonald's at S. West Street (south). Our office building is on the left side of the street and looks like a house. Continue driving past the office to 5th Street and make a left (east). Turn right on Lafayette (south) and park in the parking garage. (Now please see WALKING DIRECTIONS FROM PARKING GARAGE below)
